SSDI eligibility and verification screening

SOCIAL SECURITY DISABILITY OVERVIEW



SSDI is funded by a portion of the payroll taxes (FICA) that individuals pay while working. These contributions help Social Security determine what a claimant's SSDI benefit amount will be.

SSDI benefits are paid to qualifying workers who can't work due to severe illnesses or injuries that are expected to last at least one (1) year or result in death.

SSDI is an insurance benefit that individuals have paid for and earned. SSDI is not welfare. To qualify for SSDI benefits, most disabled workers must have worked and paid FICA taxes for at least five (5) out of the last ten (10) years.
